Candidates can submit their applications **Online Only** on the website <https://admission.jksbotelive.com> from **01-05-2024 to 15-06-2024** and also submit a Fee of Rs.100 (Rs One Hundred only) online through Credit Card/ Debit Card/ Net Banking/ UPI etc. The Procedure for filling application Form and Eligibility etc. of the candidates has been given in detail in the information Brochure.

Eligibility:

The applicant must:

- Be a resident of UT of Ladakh.
- Have passed 10th class Examination from a recognized Board / Institute.
- Have obtained percentage greater than or equal to 35% in aggregate in the 10th class Examination.

(Note: - However the candidates who have appeared in 10th class examination may also apply and marks certificates on the portal to be uploaded as and when available).

Documents to be uploaded with the Application Form:

The applicant has to upload the following documents in JPEG format with size not less than 50KB:

- i. Recent Passport Size Photograph.
- ii. Resident Certificate of candidate belonging to UT of Ladakh.
- iii. Qualifying Marks Certificate (10th Class) / Board Roll No Slip for appearing candidates.
- iv. Reserved Category Certificate, if any (including Sports, Tuition Fee Waiver on the Govt. Prescribed Performa duly renewed which ever applicable) and
- v. Disability Certificate, in case of differently abled persons, issued by the concerned authority.

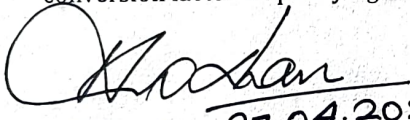
