The Engagement shall be purely on temporary basis and Guest Faculty will be terminated without any notice if the posts are filled on regular basis or conclusion of academic session whichever is earlier. Remuneration shall be paid as per Govt Order No: 26-TE&SD(UTL) of 2021 dated 27-07-2021 issued by Secretary Technical Education and Skill Development Department UT of Ladakh.

Guest Faculty Civil Engineering	B.E / B.Tech in Civil Engineering with 55% marks from a recognized University. Or 3 years Diploma with not less than 65% marks in Civil Engineering from a recognized University / Board.
Guest Faculty Computer Engineering	B.E / B.Tech in Computer Engineering / Computer Science and Engineering with 55% marks from a recognized university. Or 3 years Diploma with not less than 65% marks in Computer Engineering / Computer Science and Engineering from a recognized University / Board.
Guest Faculty Electrical Engineering	B.E / B.Tech in Electrical Engineering / Electrical and Electronics Engineering with 55% marks from a recognized university. Or 3 years Diploma with not less than 65% marks in Electrical Engineering / Electrical and Electronics Engineering from a recognized University / Board
Guest Faculty Mechanical Engineering	B.E / B.Tech in Mechanical Engineering with 55% marks from a recognized University. Or 3 years Diploma with not less than 65% marks in Mechanical Engineering from a recognized University / Board.
Guest Faculty (Mathematics, English and Communication Skills)	Post Graduate Degree in relevant subject with at least 55% Marks (50% excluding any grace marks, in case of ST/SC /differently abled).
Guest Faculty Travel and Tourism (Non-Engineering)	i) Bachelor Degree with 55% marks in appropriate branch / discipline or equivalent from recognized Institute / University ii) Bachelor Degree in appropriate arts / science / commerce with first class Diploma in the relevant discipline from recognized Institute / University. iii) 3 years Diploma in appropriate branch / discipline from recognized University/ Board. Preference will be given to category (i). In case no candidate is available from this category then preference will be given to Category (ii). In case no candidate is available from category (i) and (ii) then the candidate from category (iii) shall be taken.

Note: The Qualification obtained through Distance mode of Learning shall be governed by the Guidelines of AICTE, New Delhi and DEC (Distance Education Council) Government of India (GOI).

Criteria for formulation of merit List:

Criteria for the formulation of merit list will be as per the Guidelines for Engagement of Guest Faculty in Polytechnic Colleges issued by the Secretary Department of Technical Education & Skill Development vide order No: 26-TE&SD(UTL) of 2021 dated 27-07-2021.



Terms and Condition:

1. The selection of the candidate for engagement as Guest Faculty shall be made from eligible candidates purely on merit basis.
2. Incomplete applications not supported with requisite Documents shall be rejected without serving any notice to the candidate.
3. The engagement of Guest Faculty will be temporary and purely based on requirement of the Institution and can be disengaged as and when required.
4. The arrangement will remain for a maximum of one academic year only upto 15-12-2025 and shall automatically cease after that.
5. No pay / Honorarium shall be paid during vacation period.
6. The arrangement will be purely temporary, which shall automatically cease / terminated at any time, if any officer / official of the concerned subject / stream joins the Institute by way of transfer / Promotion / fresh appointment. The engaged guest faculty shall have no claim for continuation for the full academic year.
7. The selected candidates shall have to execute an Affidavit / Agreement with the Institute on prescribed format duly attested by the Judicial Magistrate to the effect that He / She will have no claim for permanent absorption in the department on the basis of this engagement for the specific period, at the time of joining without which He / She will not be allowed to join the institute.
8. The candidates shall have to maintain proper discipline, punctuality, Integrity and good moral character during the period of engagement. Any indiscipline shall lead to disengagement.

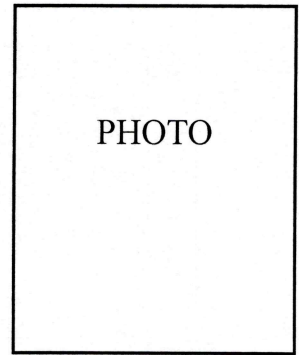
